Smolyan Municipality is a local authority responsible for all spheres of local development including culture and cultural activities. The buildings of the regional cultural institutes – museum, library, art gallery on its territory are municipal property.

Location: Smolyan Municipality is situated in the most southern parts of the country, in the heart of the Rhodope Mountains. It occupies a peripheral geographical position with respect to the borders of the country and has the potential to develop and deepen cross-border relations with the Hellenic Republic. Smolyan is 250 km away from the capital Sofia and 100 km from the second largest city in the country - Plovdiv. Only 55 km. from



Smolyan is situated the cross-border check point with Greece (Zlatograd-Thermes). Smolyan Municipality is experiencing serious challenges in terms of economic development, because of the impact of factors such as border mountainous geography. In the same time Smolyan Municipality is an important commercial and tourist center and occupies a leading position in the economy of the area.

The interaction of nature and human intervention has formed numerous cultural landscapes in the municipality. Here are many cultural values - tangible and intangible evidence of human presence and activity of high scientific and cultural value. The cultural heritage in the municipality of Smolyan is represented by archaeological, historical, architectural-construction, artistic and ethnographic sites and complexes, as well as by natural values, folk traditions and customs. The intangible cultural heritage in the municipality is represented by folk traditions, folklore and customs.

The Regional History Museum "Stoyo Shishkov" in Smolyan keeps the substantial memory of the inhabitants of the highest parts of the mountain during different historical periods. The museum is among The Hundred National Tourist Sites. www.museumsmolyan.eu.
